**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan .

On a specified date Resident #1 fell and sustained a laceration that required treatment. At the time of the incident, the resident's plan of care included the following falls prevention measures:

- risk for falls
- check every 30 minutes
- bed alarm when in bed
- keep bed in lowest position
- call bell
- Resident not to be left unattend when on the commode chair

On January 8, 2015 during interview with S100 (Nurse Practitioner) S111 (RN) and S101 confirmed that the resident was left unattended when the incident occurred.

On January 8, 2015 during an interview with S112 the Administrator confirmed that the expectation is that staff follow the care plan and that the care plan has been reviewed with all staff during report. [s. 6. (7)]
