The complaint outlined a visitor's concerns regarding an interaction observed between a resident and a staff member at Providence Manor.

During the course of the inspection, the inspector(s) spoke with personal support workers, registered staff, the Director of Care, the Administrator, and residents. The inspector reviewed the resident health record, interviewed staff, observed residents-staff interactions, as well as reviewed the Home's investigation/response documents. Multiple observations of care and service delivery through out the Home were also completed as part of the inspection.
