The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

15.(2) Every licensee of a long-term care home shall ensure that,

(c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair.

### **Findings:**

08 December 2010

The walls and door frames were damaged, deeply gouged and/or the paint was chipped or flaking off in several sections of hallway on 1st and 3rd floors as well as several resident rooms. This was identified on previous inspections.

The wooden surfaces of lounge chairs in all areas and dining room chairs presented with significant wear to the finishes as well as scratches, dents and gouges. This was identified on previous inspections.

### **Additional Required Actions:**

**VPC** - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction to be implemented voluntarily for achieving compliance with maintaining the walls, doors, lounge chairs and dining room chairs in a good state of repair.
