WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 231. Resident records

Every licensee of a long-term care home shall ensure that,

- (a) a written record is created and maintained for each resident of the home; and
- (b) the resident's written record is kept up to date at all times. O. Reg. 79/10, s. 231.

Findings/Faits saillants:

1. The licensee has failed to ensure that resident #001 and #003's written records were kept up to date at all times.

During a chart review for resident #001 documentation indicated that the resident had been hospitalized. During resident #001's hospitalization documentation was added to their chart indicating the resident's body temperature as part of the on-going infection monitoring, however the resident was not in the home during those dates. Resident #001 later died and there was documentation on the resident's body temperature again in their chart after their date of death. During a chart review for resident #003 documentation from Physiotherapist Assistant (PTA) #107 indicated that the resident was approached and had refused physiotherapy treatment, however the resident was hospitalized on that day.

It was indicated by the Director of Resident Care (DRC) that when entering the resident's temperatures, it was done as a batch entry and that the PTA should have documented the resident was unavailable, the expectation would be for staff to chart accurately.

Not keeping resident records up to date presented a potential risk for treatments or assessments to be missed.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that resident #001 and #003's written records are kept up to date, to be implemented voluntarily.
