The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): July 7 and 8, 2016

The following two complaint inspections (021122-15, 022499-15) are related to complaints regarding resident care and lack of following-up by management.

Note that other logs related to similar issues were inspected at the same time of this complaint inspection, such as Logs #008860-16, #008256-16 and #013692-16.

Non-compliance was issued; please refer to Complaint Inspection #2016_289550_0023 (Log # 010582-16) dated June 29, 2016 for findings.

During the course of the inspection, the inspector(s) spoke with the Administrator/Clinical Manager, Director of Care, Clinical Educator, Public Guardian and Trustee, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), resident and family.

In addition, the inspectors reviewed resident health care records and the home's complaint policy, and observed the delivery of resident care and services, including resident-staff interactions.
