The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 31 and February 1, 2017

The inspection was related to a fire that occurred at the home on January 30th, 2017, affecting a portion of the 3AB care unit.

During the course of the inspection, the inspector(s) spoke with the Executive Director, the Director of Care, the Facility Manager, registered and non registered nursing staff, and residents. The Inspector also spoke with representatives of the home's contracted restoration company.

The inspector reviewed information provided in a Critical Incident Report submitted by the home to the Ministry of Health and Long Term Care on January 30, 2017, relating to the fire. The Inspector reviewed documentation related to actions taken in response to the fire on January 30th, 2017. The Inspector observed the area within the home to which some residents from the affected care unit were relocated as a result of the fire, on January 30th. The Inspector observed all bedrooms in the home to which residents from the affected care unit were relocated, on January 30th and 31st, as remediation and restoration of the affected care unit proceeded.

During the course of this inspection, Non-Compliances were not issued.
