**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): January 4, 5 and 6, 2017**

**This inspection was conducted to follow upon two orders (CO)**

**CO #001, Log # 029439-16 , first issued on June 27, 2015 and re-issued on September 09, 2016. The Compliance order was issued as a result of non compliance related to duty to protect.**

**CO #001, Log # 029679-16, first issued on November 17, 2015 and re-issued on March 24, 2016 and October 06, 2016. The compliance order was issued as a result of non compliance related to the licensee code yellow policies not being complied.**

**During the course of the inspection, the inspector(s) spoke with Residents, Personal Support Workers (PSW), Personal Support Workers from external contractor, Registered Practical Nurses (RPN), Registered Nurses (RN), Housekeeping members, the Account Receivable and Resident Trust Coordinator, Food Service Supervisor, Director of Care and the Administrator.**

**During the course of the inspection, the inspector conducted a tour of the resident care areas, reviewed residents' health care records, licensee's policies and procedures on abuse and neglect and on code yellow. The inspector also reviewed the education provided to all employees on abuse and neglect and emergency process related to a missing resident. The inspector also observed resident common areas and the delivery of resident care and services.**
