Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 4, 5 and 8, 2019

The following critical incidents were inspected:

- Log # 002877-19: a critical incident report (CIS # C567-000003-19) related to an alleged incident of improper care or treatment of a resident**
- Log # 009784-19: a critical incident report (CIS # C567-000011-19) related to an incident of a missing resident > 3 hours.**

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), a Nurse Practitioner (NP), several Registered Nurses (RNs), several Registered Practical Nurses (RPNs), several Personal Support Workers (PSWs) as well as to an identified resident.

During the course of the inspection, the inspector reviewed identified resident health care records, observed staff to resident interactions, observed mechanical lifts and reviewed licensee internal investigation documents.
