During the course of the inspection, the inspector(s) spoke with 40+ residents, a representative of Family Forum, a representative of Residents' Council, Administrator, Director of Care, Office Manager, Unit Manager, three Nurse Managers, Nutrition Manager, Activities Director, Physiotherapist, Registered Dietitian, five Registered Practical Nurses, two Health Care Aides, and six Personal Support Workers.

During the course of the inspection, the inspectors: toured all resident home areas; reviewed clinical records, posting of required information, infection prevention and control practices, and relevant policies and procedures; and observed general maintenance and cleanliness, dining service, the provision of care to residents, medication administration, and staff-to-resident interactions.
