1. The licensee has failed to ensure that if the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,
 - a.) the grounds or ground on which the licensee is withholding approval;
 - b.) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;
 - c.) an explanation of how the supporting facts justify the decision to withhold approval; and
 - d.) contact information for the Director

Applicant #001 was a previous resident at the home who was admitted to a specialized unit outside the home on a specified date for assessment of the applicant's responsive behaviors. The applicant's stay at the specialized unit exceeded the 60-day leave and was subsequently discharged from the home.

The licensee received an application for approval of re-admission of the previous resident to the home on a specified date.

On a specified date the licensee provided a letter to the Community Care Access Centre (CCAC) withholding approval for re-admission of the previous resident.

The licensee's letter states that the multidisciplinary team and the staff from the specialized unit agreed the applicant would be better served on a smaller unit. The letter further states that without a change in the applicants behaviors and the recommendations from the team, the home cannot accept resident #001 at this time. No further information was provided in the letter.

The letter does not contain a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care, an explanation of how the supporting facts justify the decision to withhold approval or contact information for the Director.

It is noted that as of the inspection date, the applicant remains at the specialized unit awaiting placement in a long-term care home. [s. 44. (9)]
