**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): July 6 & 7 and July 18, 2017**

**Critical incident log # 009686-17 concerned a missing/unaccounted for controlled substance.**

**Critical incidents log #'s 008642-17 and 014103-17 concerned resident to resident abuse.**

**During the course of the inspection, the inspector(s) spoke with Residents, Personal Support Workers (PSWs), Registered Practical Nurses (RPNs), the Staff Development Coordinator, the Assistant Directors of Care (ADOCs), and the Director of Care (DOC).**

**The inspector(s) observed a medication pass, medication cart(s) and other drug storage areas. Additionally medication administration, drug destruction practices, narcotic count process (es), the home's investigation documentation and relevant policies and procedures were reviewed. The inspector also reviewed resident health records, interviewed staff, observed resident-resident & resident-staff interactions and care/service delivery as part of the inspection.**
