The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 6 - 10, 2019.

The following intakes were completed in this follow up inspection:

-One log was related to compliance order (CO) #001 that was issued during inspection #2019_771734_0002 for s. 36 of the Ontario Regulation (O. Reg.) 79/10, specific to the home ensuring that staff used safe transferring and positioning devices or techniques when assisting residents;

-One log was related to CO #002 that was issued during inspection #2019_771734_0002 for s. 131 (2) O. Reg. 79/10, specific to the home ensuring that drugs were administered to residents in accordance with the directions for use specified by the prescriber;

-One log was related to CO #003 that was issued during inspection #2019_771734_0002 for s. 131 (4.1) O. Reg. 79/10, specific to the home ensuring that nursing students may administer drugs if they do so under supervision of the member of the registered nursing staff; and

-One log was related to CO #001 that was issued during inspection #2019_771734_0003 for s. 53 (4) O. Reg. 79/10, specific to the home ensuring that strategies were developed and implemented to respond to residents demonstrating elopement behaviours.

A critical incident system inspection #2019_805638_0012 was conducted concurrently with this follow up inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), family members, and residents.

The Inspector also conducted a tour of the resident care areas, reviewed relevant resident care records, home investigation notes, home policies, personnel files and observed resident rooms, resident common areas, and the delivery of resident care and services, including staff to resident interactions.
