**2) Intake #028455-18, related to follow-up CO #002, served to the home on October 12, 2018, within report #2018\_486653\_0015, issued under r. 53 (4) of O. Reg. 79/10., related to ensuring responsive behaviour strategies were developed and implemented.**

**3) Intake #028456-18, related to follow-up CO #003, served to the home on October 12, 2018, within report #2018\_486653\_0015, issued under r. 26 (3) (5) of O. Reg. 79/10., related to plan of care based on residents responsive behaviours.**
