The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): June 15-19 and 22, 2020.

Complaint (CO) Inspection #2020_633577_0009 and Critical Incident System (CIS) Inspection #2020_633577_0010 was conducted concurrently with this Follow Up (FU) Inspection.

The following intakes were inspected during this Follow Up (FU) Inspection:

- One follow-up intake for Compliance Order (CO) #001, issued during Inspection #2020_740621_0002 under s. 8 (1) of Ontario Regulation (O. Reg.) 79/10, related to the home's medication policy; and
- One follow-up intake for CO #002, issued during Inspection #2020_740621_0002 under s. 6 (7) of the Long-Term Care Homes Act (LTCHA), 2007, related to fall's care plans.

During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), Director of Care (DOC), Assistant Director's of Care (ADOC), Registered Nurses (RNs), Resident Assessment Instrument (RAI) Coordinator, Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), and residents.

The Inspector also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions and resident to resident interactions, reviewed audits, training records, relevant health care records, and policies and procedures.
