The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): June 30 and July 2, 2014.

The following CIATT log #S-000616-14 was reviewed during this inspection.

During the course of the inspection, the inspector(s) spoke with Executive Director (ED), Assistant Director of Care (ADOC), Family members and Residents, RAI Coordinator, Personal Support Workers (PSW), and Registered Practical Nurses (RPN).

During the course of the inspection, the inspector(s) conducted a walk through of resident home areas and various common areas, observed care provided to residents in the home and reviewed resident health care records and policies.

The following Inspection Protocols were used during this inspection: Prevention of Abuse, Neglect and Retaliation

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following:

- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
- 1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity. 2007, c. 8, s. 3 (1).
- 2. Every resident has the right to be protected from abuse. 2007, c. 8, s. 3 (1).
- 3. Every resident has the right not to be neglected by the licensee or staff. 2007, c. 8, s. 3 (1).
- 4. Every resident has the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with his or her needs. 2007, c. 8, s. 3 (1).

- 5. Every resident has the right to live in a safe and clean environment. 2007, c. 8, s. 3 (1).
- 6. Every resident has the right to exercise the rights of a citizen. 2007, c. 8, s. 3 (1).
- 7. Every resident has the right to be told who is responsible for and who is providing the resident's direct care. 2007, c. 8, s. 3 (1).
- 8. Every resident has the right to be afforded privacy in treatment and in caring for his or her personal needs. 2007, c. 8, s. 3 (1).
- 9. Every resident has the right to have his or her participation in decision-making respected. 2007, c. 8, s. 3 (1).
- 10. Every resident has the right to keep and display personal possessions, pictures and furnishings in his or her room subject to safety requirements and the rights of other residents. 2007, c. 8, s. 3 (1).
- 11. Every resident has the right to,
- i. participate fully in the development, implementation, review and revision of his or her plan of care,
- ii. give or refuse consent to any treatment, care or services for which his or her consent is required by law and to be informed of the consequences of giving or refusing consent,
- iii. participate fully in making any decision concerning any aspect of his or her care, including any decision concerning his or her admission, discharge or transfer to or from a long-term care home or a secure unit and to obtain an independent opinion with regard to any of those matters, and
- iv. have his or her personal health information within the meaning of the Personal Health Information Protection Act, 2004 kept confidential in accordance with that Act, and to have access to his or her records of personal health information, including his or her plan of care, in accordance with that Act. 2007, c. 8, s. 3 (1).
- 12. Every resident has the right to receive care and assistance towards independence based on a restorative care philosophy to maximize independence to the greatest extent possible. 2007, c. 8, s. 3 (1).
- 13. Every resident has the right not to be restrained, except in the limited circumstances provided for under this Act and subject to the requirements provided for under this Act. 2007, c. 8, s. 3 (1).
- 14. Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference. 2007, c. 8, s. 3 (1).
- 15. Every resident who is dying or who is very ill has the right to have family

and friends present 24 hours per day. 2007, c. 8, s. 3 (1).

- 16. Every resident has the right to designate a person to receive information concerning any transfer or any hospitalization of the resident and to have that person receive that information immediately. 2007, c. 8, s. 3 (1).
- 17. Every resident has the right to raise concerns or recommend changes in policies and services on behalf of himself or herself or others to the following persons and organizations without interference and without fear of coercion, discrimination or reprisal, whether directed at the resident or anyone else,
 - i. the Residents' Council,
 - ii. the Family Council,
- iii. the licensee, and, if the licensee is a corporation, the directors and officers of the corporation, and, in the case of a home approved under Part VIII, a member of the committee of management for the home under section 132 or of the board of management for the home under section 125 or 129,
 - iv. staff members,
 - v. government officials,
- vi. any other person inside or outside the long-term care home. 2007, c. 8, s. 3 (1).
- 18. Every resident has the right to form friendships and relationships and to participate in the life of the long-term care home. 2007, c. 8, s. 3 (1).
- 19. Every resident has the right to have his or her lifestyle and choices respected. 2007, c. 8, s. 3 (1).
- 20. Every resident has the right to participate in the Residents' Council. 2007, c. 8, s. 3 (1).
- 21. Every resident has the right to meet privately with his or her spouse or another person in a room that assures privacy. 2007, c. 8, s. 3 (1).
- 22. Every resident has the right to share a room with another resident according to their mutual wishes, if appropriate accommodation is available. 2007, c. 8, s. 3 (1).
- 23. Every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential and to be given reasonable assistance by the licensee to pursue these interests and to develop his or her potential. 2007, c. 8, s. 3 (1).
- 24. Every resident has the right to be informed in writing of any law, rule or policy affecting services provided to the resident and of the procedures for initiating complaints. 2007, c. 8, s. 3 (1).
- 25. Every resident has the right to manage his or her own financial affairs unless the resident lacks the legal capacity to do so. 2007, c. 8, s. 3 (1).

- 26. Every resident has the right to be given access to protected outdoor areas in order to enjoy outdoor activity unless the physical setting makes this impossible. 2007, c. 8, s. 3 (1).
- 27. Every resident has the right to have any friend, family member, or other person of importance to the resident attend any meeting with the licensee or the staff of the home. 2007, c. 8, s. 3 (1).

Findings/Faits saillants:

- 1. Upon review of the Critical Incident (CI) report by Inspector #577, it was noted that an incident of abuse towards resident #001 had occurred. Documentation from the home's internal file of the incident identified staff member #S-100 referring to resident #001 in a derogatory manner. This incident was witnessed by staff members at the nursing desk. Review of the home's investigation also indicated that resident #001 was standing in front of the nursing desk. Documentation also revealed that when S #100 was corrected by a co-worker, they said they were just kidding, and became quite loud, using profanities. The licensee failed to ensure that resident #001 was protected from abuse. [s. 3. (1)]
- 2. Upon review of the Critical Incident (CI) report by Inspector #577, it was noted that an incident of abuse towards resident #002 had occurred. Documentation from the home's internal file of the incident identified staff member #S-100 referring to resident #002 in a derogatory manner. This incident was witnessed by staff members at the nursing desk. Review of the home's investigation also indicated that resident #002 was standing in front of the nursing desk. Documentation also revealed that when staff member #S-100 was corrected by a co-worker, they said they were just kidding, and became quite loud, using profanities. The licensee failed to ensure that resident #002 was protected from abuse. [s. 3. (1)]

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 9. Doors in a home

Specifically failed to comply with the following:

- s. 9. (1) Every licensee of a long-term care home shall ensure that the following rules are complied with:
- 1. All doors leading to stairways and the outside of the home other than doors leading to secure outside areas that preclude exit by a resident, including balconies and terraces, or doors that residents do not have access to must be,
 - i. kept closed and locked,
- ii.equipped with a door access control system that is kept on at all times, and iii.equipped with an audible door alarm that allows calls to be cancelled only at the point of activation and,
- A. is connected to the resident-staff communication and response system, or
- B. is connected to an audio visual enunciator that is connected to the nurses' station nearest to the door and has a manual reset switch at each door. O. Reg. 79/10, s. 9; O. Reg. 363/11, s. 1 (1, 2).

Findings/Faits saillants:

- 1. Upon initial tour of home, a door to one of the stairwell's was discovered unlocked. Inspector #597 immediately alerted staff, maintenance were notified and began repairs. The licensee failed to ensure that all doors leading to stairways are kept closed and locked. [s. 9. (1) 1.]
- WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 32. Every licensee of a long-term care home shall ensure that each resident of the home receives individualized personal care, including hygiene care and grooming, on a daily basis. O. Reg. 79/10, s. 32.

1. Upon resident observation by Inspector #577, resident #001 was unshaven and finger nails untrimmed. Reviewed resident's plan of care which identifies that resident requires support of one staff for hygiene-grooming due to impaired cognition. Two days later, resident #001 was unshaven, with food around the mouth and resident's pants very dirty and stained with spilled beverage. Observation at 1343hr of resident #001 revealed resident #001 to be unshaven and wearing soiled pants. Staff members #S-105 and #S-106 both reported that they don't know when resident #001 was last shaven. Staff member #S-104 verified through the Electronic Medical Record, that there is no documentation in past 30 days that indicates resident #001 has been shaved. The licensee failed to ensure that resident #001 received individualized personal care, including hygiene care and grooming on a daily basis. r. 32 [s. 32.]
