The purpose of this inspection was to conduct a Follow up inspection.

NOTE: A Written Notification related to Long-Term Care Homes Act (LTCHA), 24 (1), and a Compliance Order was re-issued related to LTCHA, s. 19 (1), that was identified in a concurrent inspection #2021_739694_0015, Log #003425-21, related to alleged abuse was issued in this report.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Nursing and Personal Care (DONPC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), activation staff, and residents.

The inspector also toured the home, observed the provision of care and services, reviewed relevant documents, including but not limited to clinical records, policies and procedures, internal investigation and training records.

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :



1. The licensee has failed to ensure a resident was protected from abuse by a staff member in the home.

Section 2 (1) of the Ontario Regulation 79/10 defines verbal abuse as “any form of verbal communication of a threatening or intimidating nature or any form of verbal communication of a belittling or degrading nature which diminishes a resident’s sense of well-being, dignity or self-worth, that is made by anyone other than a resident”.

Multiple staff heard a staff member raise their voice and argue with a resident.

The resident cried after the incident and stated they hated being treated like a child.

Failing to ensure the resident was protected from verbal abuse by a staff member belittled and upset the resident.

 - 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
 - 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
 - 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. The licensee has failed to ensure that a person who had reasonable grounds to suspect abuse of residents reported the alleged abuse immediately to the Director in accordance with s. 24 (1) 2 of the LTCHA. Pursuant to s. 152 (2) the licensee is vicariously liable for staff members failing to comply with subsection 24 (1).

The following is further evidence to support the order issued on March 3, 2021, during inspection 2021_792659_0003 to be complied by April 5, 2021.

Staff witnessed a staff member exhibit verbally abusive behaviour towards residents. The incidents were not reported until three days later, when a critical incident report was submitted to the Director.

Staff not reporting the suspected verbal abuse immediately, put residents at further risk of harm by the staff member.

The licensee has failed to comply with compliance order #001 from inspection number 2020_800532_0026, issued January 18, 2021, with a compliance due date of February 19, 2021.

Multiple staff heard a staff member raise their voice and argue with a resident.

An order was made by taking the following factors into account:

Severity: A resident was caused actual harm after they felt belittled by a staff member.

Scope: One out of two residents were affected.

Compliance history: In the last 36 months the home had previous non-compliance to the same subsection that included compliance order #001 from inspection 2020_800532_0026 issued January 18, 2021, with a compliance due date of February 19, 2021. Six other compliance orders, seventeen voluntary plan of corrective action (VPC) and twenty-nine written notifications (WN) have been issued. (694)
