The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

**WN #1:** The Licensee has failed to comply with O.Reg. 79/10, s.24(9) The licensee shall ensure that the resident is reassessed and the care plan is reviewed and revised when,

- (a) the resident's care needs change;

### Findings:

- A resident's plan of care updated October 29, 2010 was not revised to reflect implemented changes to the resident's care needs.

**WN #2:** The Licensee has failed to comply with O.Reg. 79/10, s. 231 Every licensee of a long-term care home shall ensure that,

- (b) the resident's written record is kept up to date at all times.

### Findings:

- The resident's written record was not up to date with details of a situation which involved a family member, the resident and staff and the outcome for the resident.

**VPC** - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to documentation within the resident's written record, to be implemented voluntarily.

**WN #3:** The Licensee has failed to comply with O.Reg. 79/10 s.131 (3) Subject to subsections (4) and (5), the licensee shall ensure that no person administers a drug to a resident in the home unless that person is a physician, dentist, registered nurse or a registered practical nurse

### Findings:

- November 16, 2010 a registered staff did not observe administration of medications to a resident.
