This inspection was conducted as the result of an info Line complaint log #032095-15 from the placement co-ordinator at the Champlain Community Care Access Centre (CCAC) on behalf of the applicant, regarding the licensee withholding approval of the application provided to them for review at the time of review for a bed availability in the home.

During the course of the inspection, the inspector(s) spoke with the home's Executive Director(ED), the placement co-ordinator at the Champlain Community Care Access Centre (CCAC), and the Acting Director of Care in the home

- 1. The licensee has failed to ensure that when they withhold approval for admission, the licensee shall give the persons described in subsection (10) being the applicant, the Director and the appropriate placement co-ordinator a written notice setting out, specifically related to the following:
- (b) A detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;
- (c) An explanation of how the supporting facts justify the decision to withhold approval.

On a specified date in October 2015, the home provided applicant #001, the Director and Placement Co-ordinator #100 at the Champlain CCAC, a written notice of withholding approval of the applicant from their wait list. This written notice identified the applicant as having very complex and chronic mental health needs, and the lack of nursing expertise necessary to meet the applicants care requirements. This decision was based on information provided in the applicant's Minimum Data Set (MDS) assessment, the Health Assessment from a specified dates in May 2015 and a conversation with the applicant's psychiatrist on a specified date in June 2015.

The Executive Director(ED) indicated to Inspector #547 during an interview that the home did not require additional information to clarify any concerns related to the applicants care needs. The ED indicated that he had a note from a specified date in October, 2015's decision for this applicant indicating that this file was withheld based on the applicant's chronic mental health issues and lack of nursing expertise for these mental health needs, adding his/her complexity of physical health related issues would not be a suitable admission to their home.

This written notice did not provide any detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and the requirements for nursing care they could not provide.

This written notice also did not provide any explanation of how the supporting facts justify the decision to withhold approval. [s. 44. (9)]
