Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 12 and 13, 2019

The following critical incidents were inspected:

- Log # 011159-19: a critical incident report (CIS # 0943-000005-19) related to an incident that causes an injury to a resident for which the resident is taken to hospital and which results in a significant change in the resident's health status
- Log # 013679-19 : a critical incident report (CIS # 0943-000006-19) related to an incident that causes an injury to a resident for which the resident is taken to hospital and which results in a significant change in the resident's health status

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), to several Registered Nurses (RNs), to several Personal Support Workers (PSWs), to the RAI Coordinator, to the Manager of Activities and Restorative Care, as well as to several residents.

During the course of the inspection, the inspector reviewed several resident health care records, observed the provision of resident care and services, observed several resident rooms as well as observed resident fall prevention interventions and mobility equipment.
