WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 72. Food production

Specifically failed to comply with the following:

s. 72. (7) The licensee shall ensure that the home has and that the staff of the home comply with,

**(c) a cleaning schedule for the food production, servery and dishwashing areas.
O. Reg. 79/10, s. 72 (7).**

Findings/Faits saillants :

1. The licensee failed to ensure that the cleaning schedule was complied with for:
 - the food production areas and
 - dishwashing areas

A General Observation revealed that there were multiple cleaning deficiencies in the main kitchen.

The Nutrition Manager reported that there was a schedule that outlined the routines and it was the responsibility of the staff to keep the kitchen clean and initial the dietary cleaning schedule once completed.

However, a review of the dietary cleaning schedule revealed that it was not being completed as assigned.

The Nutrition Manager confirmed the above observations and stated in a telephone interview that the expectation was that the staff keep the kitchen clean and initial on the routine as they complete the task, however, they did not comply with the schedule as assigned. [s. 72. (7) (c)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the cleaning schedule is complied with for:***

- the food production areas and***
- dishwashing areas, to be implemented voluntarily.***
