The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with a resident, a family member, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), two Nurse Managers (NM), the home's Behavioural Support Outreach Worker, (BSO), Senior Administration Clerk, the Director of Nursing and the Administrator.

The inspector reviewed the resident's health care records, the home's Urinary Continence Management policy #RC-0520-00, published 01-04-2016, the Management of Bowel Function policy #RC-0520-04, published 01-04-2016, and the resident's unit TENA product sheet.
