During the course of the inspection, the following complaint intakes were inspected:

- Log #009354-17, related to resident accommodation in the home, sleep patterns, care conference, responsive behaviours, and medication administration.
- Log #009967-17, related to continence care and bowel management.

During the course of the inspection, the inspector reviewed staff schedule, clinical health records, and relevant home policies and procedures.
