The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: : The Licensee has failed to comply with LTCHA, S.O. 2007, Chapter 8, S.44(14)1

44(14) If a reassessment required under clause (11) (a) has been done since the licensee approved the applicant's admission to the home, the appropriate placement co-ordinator shall give the licensee a copy of the reassessment and the licensee shall review the reassessment in accordance with the following:

1. The licensee may withdraw the approval only in the circumstances set out in clauses (7) (a) to (c), and such a withdrawal may only be made in accordance with the requirements provided for in the regulations.

#### Findings:

The home's reasons for refusing the identified resident's application for admission to the home do not meet legislative requirements. The home had previously approved the resident to the waiting list for admission to the home. A reassessment was completed and was forwarded to the home, however, when a bed became available at the home, the home withdrew approval for the resident to be admitted. In relation to the reassessment received from the CCAC, the Director of Care and the Admissions Coordinator provided the following reasons for withdrawal of approval for admission to the home.

- 1) The home refused admission because the available room was in a location that the home felt was not appropriate for this identified resident due to the resident's health condition.
- 2) The home refused admission because the applicant was considered to be "heavy care" and the available room was located on a "light care" unit. The "light care" unit does not have the staffing to support the applicant's need for a mechanical lift, as well as to support the applicant's needs regarding personal care.

These reasons do not meet the criteria for refusal of admissions as listed in clauses (7) (a) to (c).
