necessary to effect the re-admission and the following modifications are made  
respecting the application of Part III of the Act:**

- 1. The person shall be deemed to be eligible for admission to the home.**
- 2. The person is not required to make the application for authorization of  
admission in writing.**
- 3. The licensee shall be deemed to have approved the person's admission  
under subsection 44 (7) of the Act.**
- 4. The person shall be placed in the re-admission category of the waiting list  
referred to in section 177 or section 202, whichever applies, unless the person  
would otherwise be placed in a higher ranking category.**
- 5. The appropriate placement co-ordinator shall authorize the admission only if  
the person consents to the admission. O. Reg. 83/20, s. 3.**
