The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 14, 29, 2015

An inspection (2014-322156-0016) was previously conducted on September 29, 30 and October 1, 2014 at which time 3 Orders were issued. Order #001 was related to resident access to hot steam tables and Orders #002 and #003 were related to interior and exterior door locking mechanisms and alarms. For this follow-up visit, the conditions laid out in the Orders have been met.

During the course of the inspection, the inspector(s) spoke with the Executive Coach of Housing and the Clinical Education Coach. The Inspector toured both the SVO and SVII buildings and tested alarms and locking mechanisms on interior stairwell doors, locking mechanisms on balcony and courtyard doors, locking mechanisms and alarms on doors leading to unenclosed outdoor areas and verified that steam tables located in various serveries were supervised by staff or were not accessible to residents when turned on.
