WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services Specifically failed to comply with the following subsections:

- s. 15. (2) Every licensee of a long-term care home shall ensure that,
- (a) the home, furnishings and equipment are kept clean and sanitary;
- (b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and
- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants:

- 1. Surfaces behind the steamer and the coffee/hot water station located in the kitchen are not in a good state of repair. The flooring and wall behind the steamer unit (beside the oven) is not smooth, tight-fitting (to prevent water penetration) and has exposed splintered plywood on the floor. Wall paint is peeling in and around the steamer unit. The floor and wall surfaces beside the coffee/hot water station is damaged by moisture and is not tight-fitting and easy to clean.
- 2. Two sections of water pipe in the basement are not in a good state of repair. One area, located in a storage room, had a heavy drip coming down from a valve, which was heavily coated in a green layer of copper and calcium precipitate. Another area, above employee lockers had a slow drip, whereby the source was not evident.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance for ensuring that the home, furnishings and equipment are maintained in a safe condition and in a good state of repair, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 88. Pest control Specifically failed to comply with the following subsections:

s. 88. (1) As part of organized programs of housekeeping and maintenance services under clauses 15 (1) (a) and (c) of the Act, every licensee of a long-term care home shall ensure that an organized preventive pest control program using the services of a licensed pest controller is in place at the home, including records indicating the dates of visits and actions taken. O. Reg. 79/10, s. 88 (1).

1. An organized preventive pest control program using the services of a licensed pest controller is in place at the home which includes records indicating the dates of visits, however all of the actions taken have not been documented.

The pest control contractor visits the home monthly to deal with pests (or as often as needed). Records were reviewed for the months of August, September and October and the contractor notes that flies are an issue in the kitchen and what the home can do to manage them. The home was given a drain product which they used, replaced many pipes and eliminated hidden sources of water. However, the records do not indicate what was done by the pest control contractor to deal with the fly activity that was documented as being a problem. As a result, the flies continue to infest the kitchen and basement area, especially in the lunch room.
