The purpose of this inspection was to conduct a Critical Incident System inspection.

- One intake related to medication management system.**

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Manager of Quality and Compliance, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), family members and Residents.

Inspector(s) also conducted daily tours of the resident care areas, observed the provision of care towards residents, reviewed relevant licensee policies, procedures, programs, internal investigation documents and resident health care records.
