**The following Critical Incident System (CIS) report inspections were carried out:**

- CIS report, intake #017579-17, related to resident to resident alleged abuse
- CIS report, intake log #022251-17, related to resident to resident alleged abuse
- CIS report, intake #004198-18, related to care not provided to the resident
- CIS report, intake log #004139-19, related to an identified injury which resulted in the resident transfer to hospital for further assessment.
- CIS report, intake log #006011-19, related to alleged neglect related to identified care not being provided.

**A Voluntary Plan of Corrective (VPC) action related to s. 6 (7) of the Long-Term Care Homes Act, S.O. 2007, was identified in this report for resident #001 and will be issued under concurrent Complaint Report inspection report #2019\_684604\_0008, intake #006737-19.**

**During the course of the inspection, the inspector(s) spoke with the Associate Director of Care (ADOC), Physiotherapy (PT), Registered Nurse (RN), Registered Practical Nurse (RPN), and Personal Support Worker (PSW).**
