Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect

Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee failed to protect an identified resident from neglect. The licensee has a compassionate care policy in place to uphold every resident or Substitute Decision-Makers (SDM) right to make an informed decision regarding the level of intervention for irreversible or irreparable conditions. There are four levels of intervention in place.

The residents current level of intervention as per the Substitute Decision-Maker is level four which requires transfer to an acute care hospital with cardiopulmonary resuscitation (CPR) and for CPR to be initiated in the event of a witnessed cardiac arrest.

2. On a specified date, the resident required a transfer to hospital. A Do Not Resuscitate(DNR)form was signed by a staff member on the instruction from the Director of Care without receiving consent from the resident's SDM. The resident was transferred to the hospital and returned to the home with no harm.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the identified resident is protected from neglect. This plan is, to be implemented voluntarily.
