WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants:

1. A Registered Practical Nurse (RPN) overheard a Personal Support Worker (PSW) yelling at a resident. This RPN provided a documented statement to the homes administrative staff that the PSW was rude to the resident stating "I don't have time for this, are you coming for your bath or not". The PSW was observed in the hallway throwing their hands in the air stating "I can't deal with this". The PSW was observed reentering the residents room and continued to argue with the resident. The resident was observed by the RPN crying and questioning why the PSW "keeps yelling at me and I'm afraid". The PSW approached the resident a third time continuing to yell at the resident "that their time was being wasted". Following the bath the resident reported being afraid and feared that the "PSW would really be mad" for reporting the incident.

The PSW who abused the resident attended a mandatory abuse training session in 2011.
