The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 3-6, 9, 2021.

Log #011112-21 (CIS #2640-000016-21)-resident fall that resulted in an injury.

During the course of the inspection, the inspector(s) spoke with a Personal Support Worker (PSW), a Registered Practical Nurse (RPN), a Registered Nurse (RN) and the Director of Care (DOC).

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 107. Reports re critical incidents

Specifically failed to comply with the following:

s. 107. (3) The licensee shall ensure that the Director is informed of the following incidents in the home no later than one business day after the occurrence of the incident, followed by the report required under subsection (4):

- 1. A resident who is missing for less than three hours and who returns to the home with no injury or adverse change in condition. O. Reg. 79/10, s. 107 (3).**
- 2. An environmental hazard that affects the provision of care or the safety, security or well-being of one or more residents for a period greater than six hours, including,**
 - i. a breakdown or failure of the security system,**
 - ii. a breakdown of major equipment or a system in the home,**
 - iii. a loss of essential services, or**
 - iv. flooding.**
- O. Reg. 79/10, s. 107 (3).**
- 3. A missing or unaccounted for controlled substance. O. Reg. 79/10, s. 107 (3).**
- 4. An injury in respect of which a person is taken to hospital. O. Reg. 79/10, s. 107 (3).**
- 5. A medication incident or adverse drug reaction in respect of which a resident is taken to hospital. O. Reg. 79/10, s. 107 (3).**

Findings/Faits saillants :

- 1. The licensee has failed to ensure the Director was informed within one business day of an incident that caused injury to a resident for which the resident was taken to hospital and that resulted in a significant change in the resident's condition.**

A resident sustained a fall and was sent to hospital for further assessment. The resident returned to the home with an injury that resulted in a significant change in their condition. A critical incident was submitted six days later to notify the Director of this fall that resulted in a significant change in the resident's condition.
