The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 15-19, 2017.

This Follow-up Inspection is related to five compliance orders (CO) issued from inspection #2016_336620_0020. CO #001, s. 15. (1) was related to the home's organized program of maintenance services for the home, CO #002, s. 19. (1) was for a Personal Support Worker following the home's Zero Tolerance of Abuse Policy, CO #003, O.Reg 79/10 s. 15. (1) is in relation to conducting and maintaining bed entrapment assessments, and bed rails, CO #004, O.Reg 79/10 s. 130 was related to the home's drug storage area, and CO #005, O.Reg 79/10 s. 221. (1) is in relation to training of staff who apply physical devices including PASDs, the skin and wound program and the responsive behaviour program.

A Critical Incident inspection was conducted concurrently with this inspection. For details, see inspection #2017_669642_0009.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Maintenance Staff, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), residents, and family members.

During the course of the inspection, the Inspector directly observed the delivery of resident care, staff to resident interactions, resident to resident interactions, conducted a daily tour of resident home areas, reviewed resident health care records, reviewed various home policies, procedures and programs and reviewed staff education records.
