The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): April 20-22, 2021.

#2020_805638_0014, where the home was ordered to comply with section 101 subsection 3 of the Long-Term Care Homes Act (LTCHA), 2007, related to the licensee ensuring they complied with the LTCHA, the Local Health System Integration Act, 2006, the Connecting Care Act, 2019, the regulations and every directive issued, order made or agreement entered into under this Act and those Acts, with a compliance due date of February 26, 2021; and,

-One log related to compliance order #002 from inspection report

#2020_805638_0014, where the home was ordered to comply with section 17 subsection 1 of the Ontario Regulations 79/10, related to the licensee ensuring that the home was equipped with a resident-staff communication and response system that was available in every area accessible by residents, with a compliance due date of February 26, 2021.

A Complaint inspection #2021_853692_0005 and a Critical Incident System inspection #2021_853692_0007 were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Executive Assistant to the DOC, Building Services, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), and residents.

The Inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident and resident to resident interactions, observed infection control practices, reviewed relevant health care records, as well as licensee policies, procedures and programs.
