WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

- s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,**

Findings/Faits saillants :

1. The licensee did not ensure the policy named "Food Services Temperatures" revised on January 8, 2013 was complied with. The policy directs staff to ensure food temperatures for hot holding/serving of hot foods to be held at 140 degrees Fahrenheit (F) or hotter. On May 14, 2014 food temperatures were checked on Hillcrest home area during the breakfast meal. The food temperatures were taken immediately after the last meal was served and were noted to be less than 140 F. The scrambled egg was noted to be 120 F. Gardenway home area was checked and the scrambled egg and the pureed bread were noted to be 120 F. The dietary staff confirmed the temperature using their thermometers. The dietary staff also indicated the portable servery they use was unplugged during the entire meal and they do not routinely take temperatures during the meal service or at the end of the meal service. The Food Service Manager also confirmed monitoring of food temperatures is not done during the meal or at the end of the meal. The licensee did not ensure the home's policy related to food temperatures was monitored to ensure food is served at a temperature greater than 140 F. [s. 8. (1) (b)]
