Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**
(a) the planned care for the resident; 2007, c. 8, s. 6 (1).
(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).
(c) clear directions to staff and others who provide direct care to the resident.

Findings/Faits saillants :

1. The licensee has failed to ensure that their written plan of care provides clear directions to staff and others who provide direct care to the resident.

On a specified date a complainant advised they had been told that a resident required specific treatments and related interventions and they were unsure as to whether the resident is receiving the required treatments and interventions

A review of the current care plan in the unit's care plan binder and the electronic record, indicated that the resident required a specific treatment. The hard copy treatment administration record (TAR) indicated that the treatment is no longer required; this was confirmed with nursing staff and in a MDS assessment. The ADOC explained that if there is conflicting written and verbal information specific to a resident's care the most up to date information can be obtained in the unit's care plan binder and that any interventions in the care plan should match those found in the TAR and the electronic plan of care.

The home failed to ensure the written plan of care provides clear direction to staff and others as hard copy and electronic information indicate that resident #001 requires a specific treatment, and this is contrary to interview and current treatment administration documentation which indicate the treatment is no longer required.

The licensee has failed to ensure that their written plan of care provides clear directions to staff and others who provide direct care to the resident. [s. 6. (1) (c)]
