The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 4, 5, 11 & 12, 2018

The inspection included log # 014787-18 - CO #001 regarding neglect, CO #002 regarding documentation and log #019340-18 CO #001 regarding improper care provision.

During the course of the inspection, the inspector(s) spoke with residents, family members, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the Food Services Director (FSD), Dietary staff, the Registered Dietician (RD), the Assistant Directors of Care, the Director of Care (DOC), Business Office staff and the Administrator.

In addition, observations of resident care, meal service(s) delivery on multiple resident home areas, and the provision of physiotherapy services were completed. A review of electronic and hard copy records, relevant Long-Term Care home policies including Abuse/Neglect and Clinical Handover, as well as dietary services documentation and resident care flow sheets were also conducted.
