Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): March 7, 8 and 10, 2022

This inspection was to follow up on two outstanding Compliance Orders (CO): CO #001 related to the duty to protect residents from abuse and neglect with a compliance due date of January 28, 2022 and CO #001 related to the use of bed rails in the home with a compliance due date of February 25, 2022.

During the course of the inspection, the inspector(s) spoke with the Administrator (A), Director of Care (A), Human Resource Manager, Registered Nurses, Registered Practical Nurses, Personal Support Workers and Residents.

The Inspector observed the resident care environment including bed systems, reviewed resident health care records, the policy to promote zero tolerance of abuse and neglect of residents and training records for staff related to abuse and neglect.
