The purpose of this inspection was to conduct a complaint inspection.

During the course of the inspection, the inspectors spoke with the identified resident's Estate Trustee, the Home's President and CEO, Director of Care, Manager of Support Services, three Registered Nurses, one Registered Practical Nurse, two Personal Support Workers and a Housekeeper. The inspectors also spoke with an Ottawa Hospital Social Worker and the Medical Arts Dispensary Pharmacy Manager.
