Specifically failed to comply with the following subsections:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits sayants :**

1. An identified resident's plan of care indicates to ensure bumper pad are in place and secured with velcro straps on bedrails
2. The health care aid states that they are required to ensure bumper pad are in place secured on the bedrails when the resident is in bed.
3. The interdisciplinary progress note indicates that the staff received resident, bedrail cover was not on bed.
