The purpose of this inspection was to conduct a Critical Incident System inspection.

An inspection was conducted in regards to Log # 003566-20: a critical incident report (CIS # C569-000017-20) related to the unexpected death of a resident.

During the course of the inspection, the inspector(s) spoke with the Vice President of Nursing Services, the Assistant Vice Present of Nursing Services, a Registered Nurse (RN), a Registered Practical Nurse (RPN), several Personal Support Worker, the Food Service Supervisor and a Dietary Aide.

During the course of the inspection, the inspectors reviewed a resident's health care record, reviewed the texture modified menu, observed several resident rooms as well as a resident home area's common use spaces.
