**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care**

**Specifically failed to comply with the following subsections:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits saillants :**

The licensee has failed to ensure that the care is provided to the resident as specified in the plan of care. On three different occasions the interventions were not followed and resulted in minor injuries for the resident.

**Additional Required Actions:**

*VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure specific intervention for an identified resident is followed and that the care is provided to the resident as specified in the plan of care., to be implemented voluntarily.*

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 22. Licensee to forward complaints**

**Specifically failed to comply with the following subsections:**

**s. 22. (1) Every licensee of a long-term care home who receives a written complaint concerning the care of a resident or the operation of the long-term care home shall immediately forward it to the Director. 2007, c. 8, s. 22 (1).**

**Findings/Faits saillants :**

1. The Licensee has failed to forward immediately a written complaint to the Director. Complaint letter dated December 6,2011 from a family member regarding the care of a resident and the response letter dated December 8, 2011 from Linda Chaplin (Administrator)were sent to the Director on December 14, 2011.
