The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): June 13, 15, 18 and 20, 2018.

The following Critical Incidents were inspected in this Critical Incident Inspection:

Log # 011271-18, CIS#2735-000008-18 related to a Public Health declared Acute Respiratory Infection (ARI) Outbreak from May 28, 2018 to June 5, 2018. A trend was identified with three ARI Outbreaks within the last six months including CIS#2735-000002-18, and CIS#2735-000004-18.

During the course of the inspection the LTCH Inspector toured the home, observed resident care and services, reviewed relevant documents including but not limited to: clinical records, and the home's documentation and procedures as related to the inspection, and interviewed staff.
