1. The Licensee failed to ensure all doors leading to the outside of the home were locked.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure all doors leading to stairways and outside the building are kept locked, to be implemented voluntarily.
