**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning
Specifically failed to comply with the following:**

s. 71. (4) The licensee shall ensure that the planned menu items are offered and available at each meal and snack. O. Reg. 79/10, s. 71 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure planned menu items were offered and available at each meal.

Nutritional Manager (NM) #102 was interviewed in regards to the planned menu items. They indicated on three occasions from November 1, 2018 to date of this inspection, the home altered the planned menu items to respond to unanticipated staffing issues that were all weather related.

According to NM #102, all three of the changes were made to the dinner menu and residents were offered sandwiches, soup and salad as the main choice on two of the three occasions. On the third occasion, the home ordered pizza and sandwiches were offered as the alternative. Textured modified options were available. NM #102 indicated changes to the planned menu rarely occurred and that following the changes, the residents were informed of the reason for the changes.

The licensee failed to ensure planned menu items were offered and available at each meal. [s. 71. (4)]
