An inspection (2016-215123-0009) was previously conducted beginning on May 25, 2016 at which time two compliance Orders were issued related to the resident-staff communication and response system and general sanitation in food production and storage areas. For this follow-up inspection, the conditions laid out in the previous Orders have been addressed.

During the course of the inspection, the inspector(s) spoke with the Environmental Services Supervisor and Food Services Supervisor.

During the course of the inspection, the inspector toured the dining rooms, kitchen, dried goods storage area and walk-in freezer and cooler and tested the newly installed activation stations located in the main foyer and outdoor courtyard.
