**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning
Specifically failed to comply with the following:**

s. 71. (4) The licensee shall ensure that the planned menu items are offered and available at each meal and snack. O. Reg. 79/10, s. 71 (4).

Findings/Faits saillants :

1. The licensee has failed to comply with O. Reg. 79/10, s. 71(4) in that a planned menu item was not offered at a lunch meal.

On November 13, 2014, the lunch meal was observed. The daily menu stated the following items were available:

vegetable beef soup
assorted meat plate
cucumber dill salad
potato salad
dinner roll
vanilla custard

or

grilled chicken sandwich
new england vegetables
jellied fruit salad

During the lunch observation it was noted that potato salad was not included on the assorted meat plate.

During an interview with the Food Service Supervisor on November 14, 2014, she stated that the cooks did not make the potato salad at the lunch meal on December 13, 2014 and a substitute was not provided to the residents. [s. 71. (4)]

Specifically failed to comply with the following:

**s. 72. (2) The food production system must, at a minimum, provide for,
(g) documentation on the production sheet of any menu substitutions. O. Reg.
79/10, s. 72 (2).**

Findings/Faits saillants :

1. The licensee has failed to comply with O. Reg. 79/10, s. 72 (2)(g) in that menu substitutions are not documented on the production sheet.

On November 13, 2014, random production sheets were reviewed from August, September, October and November 2014. No menu substitutions were documented on the production sheets.

On November 14, 2014, the Food Service Supervisor informed the Inspector that menu substitutions were not documented on the production sheets, but rather on another form titled "Emergency Menu Changes". Some of these forms were dated with a month/year, but others had no dates and so there was no record of when the substitutions were made. [s. 72. (2) (g)]
