The purpose of this inspection was to conduct a Critical Incident System inspection.

The following intakes were inspected during this Critical Incident System inspection:

A log related to a fall.

A log related to the follow up to CO #001 issued on Feb 18, 2021, within inspection report #2021_598570_0002, related to LTCH, 2007, s. 19 (1).

A Written Notification and Compliance Order related to LTCHA, 2007, c.8, s. 6 (7) was identified in this inspection and has been issued in Inspection Report # 2021_623626_0006, dated July 8, 2021, which was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Nurse Educator, Environmental Services Manager (EMS), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), Housekeeper, Infection Control Infection Practitioner and residents.

During the course of the inspection, the Inspector reviewed residents' health record, reviewed investigation notes and relevant policies, observed staff to resident and resident to resident interactions.
