**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44. Authorization for admission to a home**

**Specifically failed to comply with the following subsections:**

- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,**  
**(a) the ground or grounds on which the licensee is withholding approval;**  
**(b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;**  
**(c) an explanation of how the supporting facts justify the decision to withhold approval; and**  
**(d) contact information for the Director.** 2007, c. 8, s. 44. (9).

**Findings/Faits saillants :**

1. The licensee failed to comply with the LTCHA, 2007 S.O. 2007, c.8, s.44(9)(c), in that when a licensee withholds approval of an applicant the written notice shall set out an explanation of how the supporting facts justify the decision to withhold approval.

The licensee withheld approval for Applicant #001. A written notice related to Applicant #001, demonstrates that the notice does not provide for an explanation of how the supporting facts, related to the home, justify the decision to withhold approval.

2. The licensee failed to comply with the LTCHA, 2007 S.O. 2007, c.8, s.44(9)(b), in that when a licensee withholds approval of an applicant the written notice shall set out a detailed explanation of the supporting facts as they related to the applicant's condition and requirements for care.

The licensee withheld approval for Applicant #001. A written notice related to Applicant #001, demonstrates that the notice does not provide for a detailed explanation of the supporting facts as they related to Applicant #001's condition and requirements for care.
