WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 241. Trust accounts

Specifically failed to comply with the following:

s. 241. (7) The licensee shall,

(a) provide a resident, or a person acting on behalf of a resident, with a written receipt for all money received by the licensee from the resident, or any other person, for deposit in a trust account on behalf of the resident; O. Reg. 79/10, s. 241 (7).

Findings/Faits saillants :

1. Written receipts are provided for all cash and cheque deposits to the resident trust accounts. Receipts are not provided for pre-authorized payment plans or deposit of government cheques that have been re-directed to the Licensee. The Licensee keeps a copy of signed agreements with the resident/SDM for pre-authorized payments or cheques that are re-directed to the home. [s. 241. (7) (a)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with the issuance of receipts to residents for deposits into their trust account from pre-authorized payment plans or cheques that have been redirected to the licensee by the resident, to be implemented voluntarily.
