The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 16 & 17, 2016

This complaint inspection was conducted regarding resident rights, and concurrently during the 2016 Resident Quality Inspection.

During the course of the inspection, the inspector(s) spoke with the Manager of Life Enrichment, a Life Enrichment Aide, the Director of Care, the Manager of Resident Services, the clerk, and two residents.

During the course of the inspection the inspector, reviewed the business file including admission and financial information for one resident, management team meeting minutes, other pertinent meeting minutes, and life enrichment calendars.

The following Inspection Protocols were used during this inspection: Dignity, Choice and Privacy Recreation and Social Activities

Specifically failed to comply with the following:

- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
- 23. Every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential and to be given reasonable assistance by the licensee to pursue these interests and to develop his or her potential. 2007, c. 8, s. 3 (1).

#### Findings/Faits saillants:

1. The licensee had failed to ensure that a resident's rights were fully respected and promoted, and that the resident had the right to pursue social interests, to develop his or her potential.

Resident #001 was invited to attend a community event as part of an organized activity by the home. There were no costs associated with the event.

An interview with resident #001 revealed that management at the home would not permit attendance at the event.

Resident #001 expressed feeling "embarrassed and sad" and that since this incident the resident has been hesitant to attend activities attended in the past, because "management won't allow it".

Interviews with the Life Enrichment Supervisor #100 & Life Enrichment Aide #101 confirmed that resident #001 was not permitted to attend the event.

Director of Nursing Care #106 indicated the homes expectation was that resident rights were fully respected and promoted, and that every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential. [s. 3. (1) 23.]

#### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that resident rights are fully respected and promoted, and that every resident has the right to pursue social, cultural, religious, spiritual and other interests, to develop his or her potential, to be implemented voluntarily.
